**Global Forest Watch** — Small Grants 2017. Global Forest Watch (GFW) is an interactive online forest monitoring and alert system designed to empower people with the information they need to better manage and conserve forest landscapes. The Small Grants Fund provides financial and technical support to non-profit NGOs that want to use Global Forest Watch in their research, advocacy, and fieldwork. The specific focus in 2017 is use of GFW's GLAD alerts and/or VIIRS fire alerts to enhance local responses to forest threats. **Critical Ecosystem Partnership Fund** — Conservation in the Indo-Burma Biodiversity Hotspot. **United States** – India Educational Foundation — Fulbright-Nehru Doctoral Research Fellowships. The Fulbright-Nehru Doctoral Research Fellowships are for Indian scholars who are registered for a Ph.D. at an Indian institution. The fellowships are for six to nine months at institutions in the USA in fields that include agricultural sciences; energy studies; urban and regional planning (with emphasis on smart cities and waste management); materials science (with emphasis on environmental applications); and others.
